I am to appreciate your continuous support for National Apprenticeship Training Scheme (NATS) of Ministry of Education, Government of India.

With reference to the subject, we are pleased to intimate you the revised rates of stipend with effect from 01.04.2021, which has been detailed in below table. Arrears of stipend are also payable to those apprentices who have undergone apprenticeship training in the period covering 01.04.2021 to till date.

Further, this Board has been mandated to implement apprenticeship training to Graduates of general stream such as B.A., B.Sc., B.Com. also with immediate effect. Apprenticeship Training period for general streams may be a minimum of 6 months and a maximum of 3 years. However, reimbursement of Govt. share of stipend to training establishment/industry will be limited to the period of 12 months only.

The establishments are requested to ensure that 'not less than the minimum amount of stipend as prescribed' has been paid to the apprentices' w.e.f. 01.04.2021. However, higher amount of stipend can be paid to apprentices, but reimbursement of Govt. share will be restricted to the amount mentioned in last column of above table.
